(Also referred to as a Certificate of Good Standing or Certificate of Existence) A Certificate of Status may be obtained by submitting a written request to the New York State Department of State, Division of Corporations, One Commerce Plaza, 99 Washington Avenue, Albany, NY 12231. The written request must include the following information:

### Division of Corporations, State Records and Uniform ...

On the specific date and time the Department issues a certificate verifying that a business entity is in "good standing," it means that all documents and fees required by law to be submitted to the Department have been received, and that no other government agency has notified the Department that the entity is delinquent in tax payments.

There are two types of certificate of good standing. Long form- A certificate of good standing confirms the status of the entity and lists all documents on file. Short form- A certificate of good standing reflects the existence status of an entity but does not list what documents have been filed.

When an entity is in good standing with the chartering agency, it may obtain a "certificate of good standing" which indicates this to be the case. In some cases, a bank may require an entity wanting to open an account such as a checking or savings account to show a certificate of good standing from the chartering agency.
